

Announcement of the Phrae Primary Educational Service Area Office 2

Subject: Amendment to the Recruitment Announcement for Foreign or Thai English Teachers

Under the One District One Quality School Project for the Academic Year 2025

According to the announcement made by the Phrae Primary Educational Service Area Office 2 on April 29, 2025, regarding the recruitment of three English teachers—either foreign or Thai—for the One District One Quality School Project in the academic year 2025, The Office of the Basic Education Commission has since revised the qualifications for English teachers under this project to better suit the local context and facilitate the recruitment process. Therefore, the Phrae Primary Educational Service Area Office 2 has made the following amendment to Section 2.2 of the original announcement dated April 29, 2025:

- "2.2 Specific Qualifications"
- (1) Educational Background and Qualifications for Foreign English Teachers
- 1.1) Educational Background:

Must possess at least a bachelor's degree in teaching or education. In cases where the degree is in another field, the candidate must hold one of the following additional qualifications:

- (1) A Graduate Diploma in Teaching Profession (TEFL) from a university, with at least 120 study hours.
- (2) TKT (Teaching Knowledge Test) scores for Modules 1, 2, 3, and YL (Young Learners) at Band 3 or above for primary school teachers (results must be no older than 5 years from the date of score announcement).
- (3) TKT scores for Modules 1, 2, 3, and CLIL (Content and Language Integrated Learning) at Band 3 or above for secondary school teachers (results must be no older than 5 years).

- (4) Trinity TESOL Level 5 Certificate
- (5) CELTA (Certificate in English Language Teaching to Adults)

1.2) Qualifications:

- (1) Must be a native English speaker from one of the five countries: United Kingdom (England, Wales, Ireland, Scotland), United States, Canada, Australia, or New Zealand.
- (2) May also be a national of a country where English is a second or official language, such as South Africa, Netherlands, Sweden, Ireland, India, Nigeria, Ghana, Papua New Guinea, Uganda, Botswana, Malaysia, the Philippines, or Singapore.

English teachers under categories (1) and (2) are **not required** to submit English proficiency test scores from standardized testing organizations.

- (3) Nationals of countries where English is considered a foreign language, such as China, Egypt, Indonesia, Japan, Korea, Nepal, Taiwan, Zimbabwe, Saudi Arabia, Vietnam, and Myanmar, must:
- (3.1) Provide English proficiency test scores covering all four skills (listening, speaking, reading, and writing) at CEFR level B2 or higher. The results must be issued within the last 2 years from the test date or the date on the score certificate. Alternatively, candidates may submit results from free online English tests; however, the testing platform must include identity verification and proctoring systems before, during, and after the test. Otherwise, such results will not be accepted.
 - (2) Educational Background and Qualifications for Thai English Teachers
 - (1) Must possess at least a bachelor's degree with a major in English.
- (2) If the candidate holds a degree in a non-English or non-education field, they must have one of the following additional qualifications:
- (2.1) A Graduate Diploma in Teaching Profession with a major in English or English language teaching.
- (2.2) TKT scores for Modules 1, 2, 3, and YL at Band 3 or above for primary school teachers (valid within 5 years).

(2.3) TKT scores for Modules 1, 2, 3, and CLIL at Band 3 or above for secondary school teachers (valid within 5 years).

(2.4) Trinity TESOL Level 5 Certificate

(2.5) CELTA

- (3) Must present a CEFR-aligned English proficiency test result at B1 level or higher, covering all four language skills, valid within 2 years from the date of the test or certificate issuance. Results from free online tests without identity verification and exam monitoring systems will **not** be accepted.
- (4) Thai English teachers must hold a valid teaching license or a temporary teaching permit.

All other information remains unchanged as per the original announcement.
